Submit your completed Nomination Form with Declaration to info@knowledgechamber.org with the relevant supporting documentation and information based on the judging criteria/ guidelines;

- Nomination Fee Rs. 35,000 plus 18% GST Including Participation + Lunch + High-Tea for each award category.
- Fee includes: Participation fee, Hi-Tea and Lunch at the venue on 21st March 2022.
- Note: Nomination Fee paid through cheque / DD / online transfer by the name of "Knowledge"
- Chamber of Commerce & Industry".
- No Cash will be taken.

ELIGIBILITY CRITERIA

- Companies with minimum 10% revenue from the export sales for FY20-21 are eligible for nomination for Indian "Exporters Excellence Awards 2022".
- Annual reports /audited financial statements for FY20-21 with the completed nomination form have to be provided before the deadline stipulated in the nomination form.

- Each entry should include write up (250 Words)
- Photograph
- Personal Profile
- Achievements (Awards& Accolades received)
- Media Coverage(Articles published)
- Any other relevant details.

TIMELINE: THE Exporters Awards is organised in concurrent with Knowledge Millennium Summit. The process is very strict and all entries (correctly submitted by 28th February 2022) will be assessed by our committee. After the assessments a short list will be announced per category.

The time line for 2022 is as follows:

Stage - 1 : Competition open for entries (The deadline for submissions is Monday, 28th February 2022).

Stage - 2 : First round of judging, shortlist internally in the committee meeting on Saturday, 5th March 2022.

Stage - 3 : Live presentations (if required) by short listed nominees in front of the Committee on Monday, 14th March 2022.

Stage - 4 : Awards winners will be announced through mail (Friday, 18th March 2022)

Stage - 5 : THE Awards ceremony where all winners will be awarded at New Delhi (Monday, 21st March 2022)

DISCLAIMER: All Nominees information collected will be kept confidential. However, KCCI will not be liable for any loss resulting from the disclosure of information in the application. The committee will have the exclusive right to accept or reject any application based on its discretion and such decisions will be final. The participants shall provide all necessary support to the KCCI to validate the information. The Award categories and nomination dates can be changed / modified/cancelled as per the discretion of KCCI. The Evaluation process will be conducted by G R Foundation and will be strictly confidential.

The decision of the KCCI & Committee will be final. No calls or emails would be entertained post awards. Award winners have to be present on the day of award ceremony. Trophy and certificate will be given (if any) on the day of award ceremony only.
